#### Payment Information

Payment of \$600 per student is due at time of registration to guarantee a space in this summer program. Space is limited to 12 students. Please pay by personal check written to The Lovett School. Registration will be accepted on a first-come, first-served basis. Registration is complete only when the Registration Form, Transportation and Liability Waiver Form, and payment are completed and returned to Carol Cummings in the headmaster's office.

**Refunds:** Sherpani Partners must coordinate Career Reality hosts long before the program will begin and has set a maximum of 12 students to ensure individual attention.

If written cancellation is received:

By June 1: Full refund will be given only if there is a student on the waiting list who fills the space. Partial refund (50%) will be given if there is no student on the waiting list who fills the space.

After June 1: A full refund will be given if there is a student on the waiting list who fills the space. No refund will be given unless a student on the waiting list fills the space.

A full refund will be given if the program is cancelled for any reason.

## Transportation Agreement

The Career Reality Experience program includes opportunities to participate in career reality work experiences by visiting Atlanta area businesses located within 40 minutes by automobile of The Lovett School campus. Transportation between The Lovett School campus and the off campus location is NOT provided by The Lovett School, the Career Reality host company or Sherpani Partners.

Parents are solely responsible for and must arrange suitable transportation according to the following guidelines.

Students may be transported by their own parent.

Students may be transported by an adult (over the age of 21), not a parent, with specific written authorization from the student's parent.

Students may drive a private vehicle only with written parental consent.

Students may not leave campus or the Career Reality Experience host company before the end of the program day in a vehicle driven by another student or any driver other than the student's parent or an adult specifically authorized in writing by the student's parent.

Neither The Lovett School, Sherpani Partners, nor the Career Reality host company, nor any of their agents or employees will be liable for any consequences or actions nor negligence arising from the transportation of the student which is not directly provided by The Lovett School, Sherpani Partners or the Career Reality Experience host company.
